EN008 was originally dispatched to a brush fire but subsequent calls reported a mobile home fire. EN008 arrived to find difficult access to a travel trailer on fire. EN008 assumed Command and began extinguishing the fire.</p> <p>I arrived and performed a command transfer with EN008. They had the fire under control and were working on a primary search and had no needs.</p> <p>SO331 was assigned Safety.</p> <p>EN331 staged Level-1 at a hydrant and was assigned to make the supply to EN008. EN008 reported they found a Code-900 victim and the fire was out. EN331 was told to hold off on charging the supply line. Additional searching by EN008 revealed a Code-900 dog.</p> <p>PCSO was on/scene and were advised of the Code-900. FI331 arrived and coordinated with PCSO to investigate the fire.</p> <p>EN008 was sent to rehab and all equipment was reassembled. The scene was turned over to FI331 and Command was terminated. BC331 returned to service.</p>

Upon approach on Ina Road, Engine 334 could see flames from Tanks Land Reclamation Facility. Engine 334 was guided by RP on scene to the northwest quad of the property.</p> <p>Engine 334 found a fire on one of the large mulch piles, fire was approximately 15x15 in size with unknown extent within the pile. Engine 334 pulled a booster line and hand tools to begin fire extinguishment and attempt to contain until heavy equipment could be used by facility to assist in breaking down the pile.</p> <p>Engine 334 reported findings to Fire Alarm and requested an upgrade of assignment to Large Brush and a tactical channel. Engine 334 was given A7 for tactical channel.</p> <p>Engine 334 reported fire in large mulch pile, defensive strategy with line pulled for fire control and established Ina Command.</p> <p>Engine 333 was next in and assigned to connect to Engine 334 to utilize tank water and bring crew up with hand tools to assist Engine 334 with breaking down the pile.</p> <p>Paramedic 334 was assigned Medical and staged by other units.</p> <p>Tender 332 was assigned to stage by Engine 333 for additional water supply to Engine 334.</p> <p>BC 332 arrived on scene and completed face to face report with Command (Captain 334). Command was transferred to BC 332.</p> <p>All other units remained staged until cancelled by Command.</p> <p>Engine 334 and 333 worked with site operator utilizing heavy equipment to spread mulch pile and watch for fire extension. After pile was spread sufficiently, Engine 334 utilized Tender 332's water to complete overhaul on pile. All units than cleared the incident.</p>

EN337 started a hiker rescue response.</p> <p>EN337 staged at The Ritz and walked in approx 15-20 minutes to find a female ACOx4 but too weak to walk back out. EN377 crew used their side by side to make access to the patient and transport the patient out to PM337 who transported to NWH. All other units were canceled en route to the call. EN337 crew walked back out to the engine and went in service.</p>

EN331 arrived, reported a working incident, and assumed Command. I arrived and performed a command transfer with EN331 and assumed Palmyra Command. We remained in the offensive strategy. I observed white smoke coming from the D side about ½ way down the length of the trailer. There was dark gray smoke coming from the A/B side from the door that EN331 entered. EN331 had stretched an attack line through the A side for primary search and fire control but needed a supply line established.</p> <p>EN330 staged Level 1 at the hydrant and were assigned to make the water supply to EN331. After completing the water supply, they reported a status change and were reassigned to on-deck on the A side.</p> <p>SO 331 arrived and was assigned Safety. PM330 arrived and were assigned to secure utilities and perform door control from the exterior. PM331 was assigned to set up rehab. A CANS report was obtained from EN331 and they reported low heat and zero visibility. They were unable to locate the fire. Smoke was starting to turn brown from the A side and there was more smoke coming from the D side. EN331 was advised of this and continued to search for the fire. Shortly after, fire began to burn through a door on the D side.</p> <p>EN330 was reassigned to stretch a 2nd attack line from EN331 to the exterior on the D side and work with EN331 to extinguish the fire in that area.</p> <p>EN332 was assigned on-deck. SR333 arrived and was assigned occupant services.</p> <p>EN331 reported a status change that they had found the fire, and it was under control. They also reported a primary all clear with a PAR. EN331 needed to exit to recycle.</p> <p>EN332 was reassigned to take over for EN331 interior. EN008 was assigned on-deck.</p> <p>EN332 reported the fire was out and had a secondary all-clear.</p> <p>The resident reported their two dogs were missing so EN331 crew searched from them again. They located one of the small dogs alive and well inside the home and was turned over to its owner. The second dog was located alive and well hiding under the home and was returned to its owner.</p> <p>All crews went through wash down and rehab. The scene was turned over to FI331 and Command was terminated.</p>

Mail carrier had gone to front door to drop off a package and heard smoke detectors sounding prompting 911 call. Upon arrival, nothing showing. Multiple smoke alarms were sounding in the residence. EN338 attempted to knock on door and ring the doorbell with no answer. EN338 began to do a 360 to look for signs of fire and access into the home. There was a sliding glass door on the Charlie side with no blinds, providing visual into the house where active fire and smoke conditions from ceiling to appx 3 foot height. EN338 upgraded the assignment to a full alarm, pulled a hose line to the A side front door. Resident arrived home as line was being pulled and offered his key to unlock front door, so no forcible entry was required. EN338 made entry with smoke conditions to the waist but minimal heat. EN338 located seat of fire in family room around, above and behind an aquarium and obtained knockdown with minimal water. Primary search was completed. A dog was assisted out of the home and taken by homeowner. BC332 arrived on scene and command was transferred.</p> <p>EN338 requested PPV and horizontally ventilated the residence. Area around seat of fire was assessed with TIC and hot spots were noted above and around area. Drywall was pulled and no extension noted in ceiling or walls. The aquarium was noted to be leaking heavily due to damage. Unable to determine whether damage was caused by fire or had been damaged prior to and contributed to ignition. EN338 was able to locate 5 fish that were still alive. The fish were removed from the aquarium and placed in a bucket and given to the homeowners. EN338 utilized shop vac and squeegees from AP377 to remove water from extinguishment operations and leaking from the aquarium. EN338 utilized shop vac to remove remaining water from aquarium to minimize additional water damage. EN338 removed bulk of water from residence. Fire appeared to have begun at the bottom left of the aquarium where there was a pump with major fire damage and a v pattern above. EN338 turned the scene over to the CAP team to assist the homeowners with additional services.</p>

U/A, found a large, three-story, commercial structure with nothing showing. This was a Pima College campus. EN333 assumed command and began investigating. EN333 met with an RP who stated she believed there was smoke, heat, and a strong odor coming from the woman's restroom on the third floor.</p> <p>BC380 arrived on scene and assumed command.</p> <p>EN333 made access to the affected bathroom and found water flowing from under the door with a large amount of steam present. The RP was able to unlock the door with a key. Negative signs of fire in the restroom. It was determined there was a broken, hot water pipe in the ceiling which had flooded the bathroom and damaged the paint, drywall, and drop ceiling.</p> <p>EN333 requested an air power truck and one additional suppression unit to remain on scene. The remainder of the first alarm assignment was cancelled. EN380 was assigned to locate the water shutoff to the building, however, EN333 was able to locate a quarter-turn valve in the adjacent janitor's closet which shut down the water supply to the affected pipe only. EN333 utilized squeegees and a shop vac to remove the majority of the water and drywall debris from the bathroom and surrounding area. The scene was turned back over to the campus RP who isolated the area with caution tape to prevent student access. EN333 cleared the scene and returned to service.</p>
