**Northwest Fire District (NWFD) protects the following critical infrastructure: Interstate 10 (I-10) part of the Canadian-Mexico transportation corridor, with truck volumes estimated at 13,000 trucks per day and an average daily traffic count (ADTC) of 107,000 vehicles per day (vpd); State Highway Route 77 with an ADTC of 82,000 vpd; Union Pacific Railroad (UPRR) that operates a dual track railway running through the district with an average of 50-60 trains each day; Amtrak passenger trains also run through the district several times a week; Pima County wastewater treatment plant which serves the greater Tucson area of over 700,000 residents; Marana Regional Airport, a general aviation reliever airport for approximately 300 aircraft reporting 110,000 takeoffs & landings annually; Central Arizona Project (CAP), an aqueduct that brings water from the Colorado River to the metropolitan Tucson area providing more than 144,000-acre feet of the potable water to area residents; Metro Water, Marana Water, Oro Valley Water, Flowing Wells Irrigation District and Tucson Water all have water reservoirs that store 500,000 gallons or more of potable water for community residents; Kinder-Morgan operates a multi-state, 10-inch, high pressure natural gas line that traverses the district and two large, parallel multi-state petroleum pipelines (12 in. and 16 in.) that run between I-10 and the Union Pacific railway; Bridges on Interstate 10 and the UPRR main lines over the Rillito River; Second largest cement plant in the state (Cal-Portland Twin Peaks Plant); Northwest Medical Center a 300-bed hospital; two large retail malls; an Amazon warehouse; Bayer/Monsanto 7 acre greenhouse producing**

**modified corn for seed production; three waste landfills; Town of Marana Municipal complex (includes the Court, Police Department and Administrative buildings); 19 public lower schools, 4 public high schools, and 9 charter/private schools; Pima Community College; large YMCA facility; 14 public parks, 2 land preserves, and a National Park lies within the District’s boundaries.**

Describe the planned purpose of this fund.

This fund protects the district from economic downturns, reduces the probability of taking on short term debt, and provides the ability to respond to an economic disaster. In FY2023 this fund would have provided 81.61 days of cash on hand. These funds are not available for operational expenditures without approval from the District’s Governing Board. Financial policies adopted by the board established a target of 20% of operating revenues for this fund; this has not been achieved since 2016.

**Northwest Fire District's (NWFD) financial need for federal grant assistance to purchase replacement wildland PPE is due to increased operational expenses, and legislative and voter-approved initiatives that limit the ability to generate sufficient revenue needed to replace PPE per NFPA standards. We are primarily funded through limited assessed value property taxes. Large areas of the District (63%) are agriculture, wildland, open space, or undeveloped properties that generate little tax. Multiple governmental buildings, Marana Municipal Building, Pima Community College, and numerous public schools and churches are located within the District and generate no tax revenue for the District. State legislation also impacts our revenue source. In 2009 the state legislature placed an 8% limit on tax levy increases, in 2011 they reduced the tax assessment of commercial properties and utilities by 2%, in 2012 they placed a 5% limit on assessed value increases, and in 2021 they reduced the tax assessment of commercial property by one-half percent each year until 2024. These legislative actions have constrained NWFD's revenue-generating capacity. To cover operations last year, NWFD's Governing Board approved a tax rate increase. That increase offset operating budget shortages but did not provide sufficient funding to replace aging equipment, PPE, vehicles, or complete major building repairs. This year the increase in pension and medical costs, step increases, personnel realignments, and budgeting an academy is approximately \$2.2 million. We also anticipate continued unprecedented inflationary increases in the cost of supplies and utilities, as well as several legislative items that, if passed, could have a negative impact on the District. Our AFG SAFER award ends in 2024, which will require us to fully fund the salaries and benefits of 10 firefighters (estimated 1.2 million a year). A recent project to convert the training center asphalt to concrete to address sinking issues, increased from \$1 to \$4.5 million due to the necessity of lowering utility lines to accommodate the**

increased driveway depth. The unanticipated training drive increase has necessitated all non-critical facility projects to be delayed for several years. Northwest Fire District has searched for grant funding for several years to replace the wildland gear purchased in 2006. A potential grantor was identified last year, (Pascua Yaqui Tribe shared gaming revenue), and we immediately applied. The District was not chosen as a recipient of those funds. The District's revenue source is reliant on limited assessed value property taxes which provides 78% of our operating revenue. Other funding sources (22%) include income generated from service fees (e.g., inspections, & plan reviews), Smart & Safe AZ-Prop 207 sales tax revenue (in 2023 the state legislature significantly increased eligible participants which will reduce the amount received), interest earned, rent collected for ambulance space (we anticipate loss of this contract in the next fiscal year), an intergovernmental agreement to share the cost our Community Assistance Responders, and revenue collected from participating fire districts/departments and passed through to the City of Tucson for Dispatch services. NWFD's operating budget for the FY23-24 is \$56,636,695, this includes: Personnel/Fringe - \$36,558,407; Materials & Supplies - \$1,931,775; Prof Services-\$1,594,571; Capital Outlay - \$60,000; Utilities & Communications - \$1,712,946; Insurance - \$212,976; Repairs & Maintenance - \$1,528,743; Leases - \$257,277; Transfers in/out - \$2,400,000; Contingencies/Fund Balance - \$10,380,000. Most of the operating budget funds Personnel costs (65%), leaving 35% of revenue to cover all remaining operating expenses.

**The District provides service to the town of Marana, the fifth fastest growing city in Arizona. World Population Review reports “Marana is currently growing at a rate of 2.25% annually and its population has increased by 11.27% since the most recent census”. The District also provides service to unincorporated Pima County. World Population Review reports an estimated .82% growth rate for Pima County. In 2023 a total of 1,400 single family residential units were added to the District. The Districts Fire Plans Examiner has reported the following large projects under**

**construction: 3 apartment complexes, 3 self-storage facilities, a 300,000 square foot furniture store, and a Kroger Marketplace complex. With this tremendous growth, the District estimates the need for at least 2 fire stations within the next 2-3 years to provide the needed level of protection for our community. Due to our proximity to the southern border and the inflationary economy, residents experiencing homelessness have increased substantially within the District. NWFD is located at the northern range of the Sonoran Desert, with an arid subtropical climate. Our weather is usually dry and winter evenings can reach freezing temperatures. Homeless individuals rely on fires to keep warm, which increases the incidences of brush fires within the District. Governmental entities are anticipating higher rates of homelessness due to the current political climate and border crisis.**

**NWFD is located in Pima County, AZ (pop. 1.075 mil), just north and west of the city of Tucson, (pop. 557,254), in the beautiful Southwest desert. NWFD is a special taxing District with 11 fire stations providing first response coverage for 190 sq. mi. and an estimated 135,865 residents, 43% residing in the Town of Marana (pop. 58,542), with the balance residing in the unincorporated county areas. NWFD is an internationally accredited, ISO Class 1, career department with 225 full-time firefighters actively engaged in firefighting duties. The NWFD employs a 3-shift, 3 on 4 off, 56-hr. work schedule to provide 24/7/365 coverage. In 2023, NWFD reported 18,983 responses, 73% of which were EMS/Rescue-related. It provides an “all hazards” range of emergency services including wildland fire and ALS medical transport services. It also provides public fire safety education, code enforcement, plans review, and fire investigation services to the community. The District participates in the Pima County Multi-Jurisdictional Hazard Mitigation Plan. NWFD has auto-aid agreements with the Golder Ranch Fire District and the City of Tucson. It has mutual aid agreements with 4 neighboring Fire Districts and participates in the Arizona Statewide Mutual Aid Compact. The NWFD serves a diverse socio-economic community with 10% of people living below the poverty level. A portion of the District lies within a federally identified opportunity zone. The ethnicity of the NWFD is primarily Caucasian**

(59%) and Hispanic (30%). Children under 5 years of age and adults over the age of 65 represent 41% of the overall population. People living with a disability represent more than 14% of our population. NWFD experiences a slight increase in population (est. 6,793) during the winter months due to tourism and winter resident population, including students attending the University of Arizona. NWFD serves population densities ranging from many square miles of undeveloped land to areas that exceed the U.S. Census Bureau definition of urban density. Most of the development within NWFD is residential including single and multi-family dwellings. There is a substantial presence of retail occupancies along with a smaller percentage of warehouse and industrial type facilities. The economic base in NWFD is relatively diverse and is primarily supported by many large and small retail businesses, light industry, and the health service industry. Tourism also significantly influences the economy, contributing to a sizeable number of hotels and restaurants. The District has beautiful mountain hiking trails, and extensive bicycle trails, and our winter weather is fabulous. Tucson is known worldwide for their gem show and hosts a yearly rodeo. There is a moderate number of local, county, state and federal government facilities and offices that contribute to the area economy (but not the tax base) including 19 lower schools, and 4 high schools located within District boundaries. NWFD's auto-and mutual aid agreements, along with their and HazMat and Special Operations capabilities expand its involvement to the entire metropolitan Tucson area including facilities like United Technologies Corp. (an aerospace and defense contractor); various semi-conductor facilities; a large public power generating facility; the University of Arizona; Pima Community College; and several large, open-pit copper mines. Its participation in the Tucson-area Major Medical Response System (MMRS) commits them to participate in major medical incidents like the one that occurred on January 8, 2011, when a gunman shot and killed 6 persons, including a 9-year-old female and wounded an additional 13 persons including former Congressional Representative Gabrielle Giffords. Due to NWFD's proximity to the Tucson

**International Airport, Davis-Monthan Air Force Base, and the Arizona Air National Guard, the potential for large life-loss incidents involving aircraft is ever-present.**
