MOTION:

Move to approve the utilization of Stryker on a Sourcewell Cooperative Contract for the purchase of one (1) Lund University Cardiopulmonary Assist System (LUCAS) Device and maintenance plan in the amount of \$27,000 and authorization to use Ambulance Fund balance.

DISCUSSION:

Stryker is on a Sourcewell Cooperative Contract that can be utilized for Emergency Medical Services (EMS) equipment. The District joined the Sourcewell Cooperative membership in December 2014. Individual cooperative contracts go through a competitive process with the hosting agency, but they are not approved by the Governing Board like District issued contracts.

The requested LUCAS device and maintenance plan was not included in the Adopted FY24/25 Budget, but it is necessary equipment for the ambulance that is currently in production. The Ambulance Fund balance as of February 1, 2025, is \$1,403,424 which is sufficient to cover the purchase of the LUCAS device and maintenance plan.
